New QI Initiatives

North Carolina Maternal, Infant, and Early Childhood Home Visiting Program Climbs the Data Peek

The NC Division of Public Health streamlined data collection and improved the quality of reportable data in their Maternal, Infant, and Early Childhood Home Visiting Program. The aim of this quality improvement initiative was to improve the quality of program data sent from the local sites and to streamline the entire data collection process. The project activities optimized effective use of data, so that programs are using data in a way that could identify how to strengthen and improve the services they provide to children and families. The initiative fostered and maintained a culture of quality within the home visiting program and created a positive communication feedback loop between the state and local teams. Assessing and Improving Agency-Wide Quality Improvement Training

Kane County Health Department (KCHD) has used SlideRocket to create quality improvement (QI) training modules and tracks staff progress using an internal database, which contains personal staff information and is shared internally within the Community Health Resources (CHR) section. The fiscal year (FY) 2014 QI plan states that staff must complete six required QI modules. In May 2014, only 61.7% of staff had completed all six of the required modules. Staff were surveyed about barriers of and opportunities from training module completion and use. CHR section staff and the QuIPM Committee were then surveyed about the best possible solution, which would be having the health data and quality coordinator (HDQC) send regular updates to staff with the modules they need to complete. Within days, the completion percentage increased by 10% and several weeks later had reached 83.1%. The notification is now a standard monthly process used by the HDQC, who tracks the trainings internally and collectively through the performance management system...continue reading here.

Love NACCHO's Roadmap to a Culture of Quality Website? Check out the newest revisions!

NACCHO is pleased to announce revisions to the <u>Roadmap to a Culture of Quality</u> (the Roadmap) website. The Roadmap provides local health departments (LHDs) with guidance on progressing through six phases or levels of QI maturity and presenting common organizational characteristics, strategies, and resources for transitioning toward a quality culture. Revisions include the following:


- Change management content-Change management is a cornerstone of building a
 quality culture. The Roadmap offers a new change management page that provides an
 overview of the change management process, delineating between the "human" and
 "process" sides of change and presenting instructions on how the Roadmap can be
 used to manage change and handle staff resistance.
- <u>Assessment guidance</u>-An assessment of the current culture is important to understand a path to the future desired state. New guidance on selecting a self-assessment tool based on LHD needs and experience is now available.
- Detailed organizational characteristics-Each of the <u>six phases of the Roadmap</u> now includes more detailed organizational characteristics reorganized by <u>foundational</u> <u>element</u>. The new content provides more guidance on identifying the current phase of a quality culture.
- User-friendly navigation-The phases of the Roadmap are now organized by tabs and collapsible drop-down menus, allowing users to view the most relevant content with reduced click-throughs and scrolling.
